FOREWORD

- 1) The IEC (International Electrotechnical Commission) is a worldwide organization for standardization comprising all national electrotechnical committees (IEC National Committees). The object of the IEC is to promote international co-operation on all questions concerning standardization in the electronal and electronic fields. To this end and in addition to other activities, the IEC publishes International Standards. Their preparation is entrusted to technical committees; any IEC National Committee interested in the subject dealt with may participate in this preparatory work. International, governmental and non-governmental organizations liaising with the IEC also participate in this preparation. The IEC collaborates closely with the International Organization for Standardization (ISO) in accordance with conditions determined by agreement between the two organizations.

Any divergence between the IEC Standard and the corresponding national or regional standard shall be clearly indicated in the latter.

- 6) Attention is drawn to the possibility that some of the elements of this International Standard may be the subject of patent rights. The EC shall not be held responsible for identifying any or all such patent rights.

International Standard IEC 60335-2-48 has been prepared by subcommittee 61E: Safety of electrical commercial catering equipment, of IEC technical committee 61: Safety of household and similar electrical appliances.

It forms the third edition of EC 60335-2-48 and replaces the second edition, published in 1995, and its amendment 1 (1996) and amendment 2 (1998).

The text of this standard is based on the second edition, amendments 1 and 2 and the following documents:

This part 2 is to be used in conjunction with the latest edition of IEC 60335-1 and its amendments. It was established on the basis of the third edition (1991) of that standard.

This part 2 supplements or modifies the corresponding clauses in IEC 60335-1, so as to convert it into the IEC standard: Safety requirements for commercial electric grillers and toasters.

Where a particular subclause of part 1 is not mentioned in this part 2, that subclause applies as far as is reasonable. Where this standard states "addition", "modification" or "replacement", the relevant text in part 1 is to be adapted accordingly.

NOTE 1 The following print types are used:

- requirements: in roman type;
- test specifications: in italic type;
- notes: in small roman type;

Words in **bold** in the text are defined in clause 2.

NOTE 2 Subclauses, figures and notes which are additional to those in part 1 are numbered starting from 101.

SAFETY OF HOUSEHOLD AND SIMILAR ELECTRICAL APPLIANCES -

Part 2-48: Particular requirements for commercial electric grillers and toasters

1 Scope

This clause of part 1 is replaced by:

This standard deals with the safety of electrically operated commercial **grillers** and **toasters** not intended for household use, their **rated voltage** being not more than 250 V for single-phase appliances connected between one phase and neutral, and 480 V for other appliances.

Rotary or continuous grillers and toasters and similar appliances intended for grilling by radiant heat such as rotisseries, salamanders, etc. are within the scope of this standard.

NOTE 1 These appliances are used, for example, in restaurants, canteens, hospitals and commercial enterprises such as bakeries, butcheries, etc.

The electrical part of appliances making use of other forms of energy is also within the scope of this standard.

So far as is practicable, this standard deals with the common hazards presented by these types of appliances.

NOTE 2 Attention is drawn to the fact that

- for appliances intended to be used in rehicles of on board ships or aircraft, additional requirements may be necessary;
- for appliances intended to be used in tropical countries, special requirements may be necessary;
- in many countries additional requirements are specified by the national health authorities, the national authorities responsible for the protection of labour, the national water supply authorities and similar authorities;
- for appliances intended to be used autdoors, additional requirements may be necessary.

This standard does not apply to

- appliances designed exclusively for industrial purposes;
- appliances intended to be used in locations where special conditions prevail, such as the presence of a corrosive or explosive atmosphere (dust, vapour or gas);
- continuous process appliances for the mass production of food;
- griddles and griddle grills (IEC 60335-2-38).
